

Key dates for UN Treaty Bodies reviews and the Universal Periodic Review – 2024

This table includes contains key dates for state reviews by three of the UN Treaty Bodies (Committee on the Elimination of Discrimination Against Women (CEDAW), Committee on Economic, Social and Cultural Rights (CESCR) and the Committee on the Rights of the Child (CRC)) and under the Universal Periodic Review (UPR), as well as deadlines for CSOs to engage with these mechanisms in 2024. This information is intended to supplement Girls Not Brides’ toolkit, which provides detailed step-by-step guidance on how to leverage UN human rights mechanisms to end child marriage. Hyperlinks have been included in the table to allow member organisations to easily access further relevant information to support engagement in these UN human rights processes.
